

The Arthur Napier Magill Distinguished Service Award



Nomination Package (To be completed by the Nominator)

The Arthur Napier Magill Distinguished Service Award represents the organization's highest public recognition for volunteer services and is given to an individual or group who is deemed to have made a contribution significantly above and beyond that which is normally seen. Please complete the enclosed nominations form, recognizing the stature of this award and the information needed to ensure that the nominee is fully described.

Nominations will be accepted until end of day on Sunday, May 25, 2025. Please forward the nominations form and any supporting documents to awardscommittee@cnib.ca.

Nomination criteria

The 4 criteria used to assess nominations are:

- **CONTRIBUTIONS** | to the lives of people who are blind or partially sighted
- **IMPACT** | on improving the lives of people who are blind or partially sighted
- **REACH OF SERVICE** | international, national, regional, local, number of people who benefited, individuals or groups)
- **YEARS OF VOLUNTEER SERVICE** | dedicated to volunteering at CNIB, DBCS or VLRC

How will nominations be assessed?

Nominations will undergo the review process listed below. The Selection Committee will give each nomination a score based on the written nominations response to the criteria listed above. The maximum total score for any nominations is 400 points. Be sure to provide complete descriptions for each criterion on the nominations form.

- First, The National Awards Committee made up of senior volunteers from CNIB, VLRC and DBCS, review each nominations package.
- The National Awards Committee assesses the nominations based on the set of established assessment criteria listed above and develop a list of top ranked nominations for further assessment.
- The National Awards Committee hold a final meeting to evaluate the top nominations and determine the award recipient on behalf of CNIB.
- The recipient will be informed, and all nominators will be notified. An award ceremony will be held at an agreed upon time.

Guidelines to follow when submitting a nomination

This guideline will assist you in the completion of the nominations. Before nominating a volunteer, review this guideline and gather the necessary information to support your nomination. To provide the best submission first ensure that you have completed every section of the nominations form to the best of your ability. Be sure to use specific examples and stories that illustrate how your nominee exceptionally meets the criteria.

As a volunteer nomination, include only volunteer experience gained through the three organizations: CNIB, DBCS, or VLRC. Volunteer experience with other non-profits will not be considered in assessing the nomination.

If you need additional space and/or are including letters of support, please include a separate document, and reference the attachments in the appropriate text boxes on the nominations form.

1 Some examples for each of the criteria are, but are not at all limited to:

Contributions to the Lives of People who are Blind or Partially Sighted

- Contributions to preventing blindness, maintaining vision health such as: medical or social work research or education rehabilitation services, political advocacy (such as for medical offerings or coverage), creation of new services or technology.
- Creating, leading, or administering innovative or impactful CNIB programming or camp.
- Workplace inclusion.
- Increasing ease of movement or navigation.
- Increasing use or accessibility of technology or digital offerings.
- Political advocacy (such as social inclusion or accessibility).
- Print or media accessibility.

Impact of Service on Improving the Lives of People who are Blind or Partially Sighted

- The result of the volunteer's service has impacted the lives of people who are blind or partially sighted at one moment in time or will be long lasting.
- The result of the volunteer's service will target one or many aspects of daily life.
- The result of the volunteer's service will dramatically improve daily-life for people who are blind or partially sighted and have a far reach.

Reach of Service

- The number of people that benefit from the volunteer's service.
- The scope or reach of the service (i.e., local, regional, national, number of people reached).
